

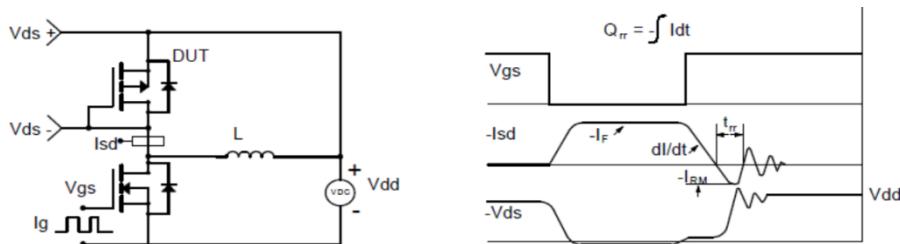
### Avalanche Test Circuit and Waveforms



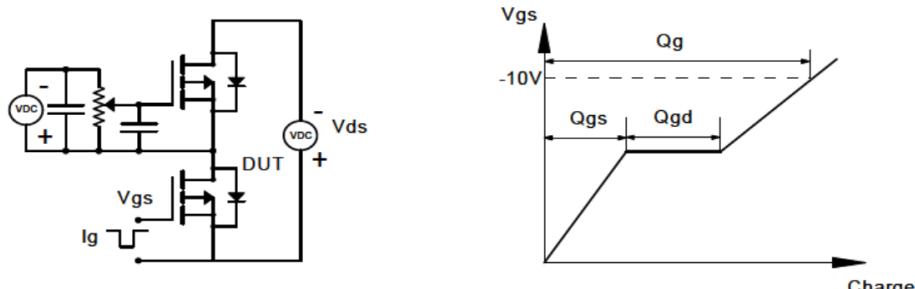
### Switching Time Test Circuit and Waveforms
